

# Canton Area Chamber of Commerce Photo Booth Rental

## **Pricing Options for Members of the Canton Area Chamber of Commerce:**

### **Option 1: Guests Pay to Play**

Set Up Fee - \$50

Booth will charge a minimum of \$1 per photo session (Photo session can include 2 strips or one large sized photo, depending on size of print out). Chamber will keep all proceeds of the booth to cover the cost of the film. (If your business or organization would like to charge more per photo strip or add “upsell” options, you may, but the Chamber will keep \$1 of every print-out to cover the cost of film).

### **Option 2: Unlimited Photos for Your Guests (Pay for what you use)**

Set Up Fee - \$50

Booth will be set up for free photos (no charge). At the end of the event, the chamber will calculate the number of print outs make and charge the renter \$1 per print-out to cover the cost of the film.

### **Option 3: Unlimited Photos for Your Guests (Pay for what you use)**

Set Up Fee - \$50

\$50 per hour for unlimited photos.

Booth will be set up for free photos (no charge to users). Chamber will bill the user at a rate of \$50 per hour for the entire length of the event.

### **A La Carte Add On :**

Upgrade to Video Messages - \$50

The following contract and its terms will set forth an agreement between Canton Area Chamber of Commerce’s (Provider) and \_\_\_\_\_ (Client) the parties, for photo booth services for an event taking place at \_\_\_\_\_. This written contract sets forth the full, written intention of both parties and supersedes all other written and/or oral agreements between the parties.

**SERVICE PERIOD**

The Service Period will be from these times: \_\_\_\_\_ to \_\_\_\_\_ on \_\_\_\_\_(Date).

Provider agrees to have the Photo Booth operational for a minimum of 80% during this period; occasionally, operations may need to be interrupted for maintenance of the Photo Booth. This service period operational time period only applies to settings that have been preset and setup by the Provider, and does not include custom templates created or modified by the Client.

Provider will arrive a minimum of 45 minutes before the above time.

**PAYMENT**

A non-refundable reservation fee in the amount of \$50 is due upon signing of this contract.

The remaining amount is due 14 days in advance of Client's Event. If there is 14 days or less before the event, payment in full will be required at booking. In the event that the Client chooses to pay per photo (Option 2), the Canton Area Chamber of Commerce will provide a bill for all photos taken within 14 days after the event. This service period operational time period only applies to settings that have been preset and setup by the Provider, and does not include custom templates created or modified by the Client.

**SET UP**

Photo booth requires appropriate space (5’ deep x 3’ wide x 6’ high total space). If the booth is placed outdoors client shall provide overhead shelter for the photo booth and sufficient protection from the elements. Client is responsible for providing power for the photo booth (110V, 15 amps, 3 prong standard outlet) within 15 feet from our designated area, however, it is recommended that client use a 15 or 20 amp GFCI Ground Fault Outlet.

The Chamber reserves the right, in good faith, to cease the operation should the weather pose a potential danger to our personnel, the equipment, or guests.

**DAMAGE TO PROVIDER'S EQUIPMENT**

Client acknowledges that it shall be responsible for any damage or loss to the Provider's Equipment caused by:

- a) Any misuse of the Provider's Equipment by Client or its guests,
- b) Any theft or disaster (including but not limited to fire, flood or earthquake), or
- c) loss of power or power surges to the photo booths at any time resulting in loss of pictures or damage of software and/or equipment.

**INDEMNIFICATION**

Client agrees to and understands the following: a) Client will indemnify provider against any and all liability related to Client's Event during or after Client's event. Client will indemnify Provider from the time of service and on into the future, against any liability associated with Client. b) Client will indemnify

Provider against any and all liability associated with the use of pictures taken within the Canton Area Chamber of Commerce's Photo Booth its representatives, employees or affiliates at Client's event.

**MODEL RELEASE OPTION**

Client agrees to and understands the following: All guests using the photo booth hereby give to Canton Area Chamber of Commerce's Photo Booth the right and permission to copyright and use, photographic portraits or pictures of any photo booth user who may be included intact or in part, made through any and all media now or hereafter known for illustration, art, promotion, advertising, trade, or any other purpose. In addition, I hereby release, discharge and agree to save harmless Canton Area Chamber of Commerce's, from any liability, that may occur or be produced in the taking of said picture or in any subsequent processing thereof, as well as any publication thereof, including without limitation any claims for libel or invasion of privacy. **MISCELLANEOUS TERMS**

If any provision of these terms shall be unlawful, void, or for any reason unenforceable under Contract Law, then that provision, or portion thereof, shall be deemed separate from the rest of this contract and shall not affect the validity
